What is Healthwatch Devon?

Healthwatch Devon is the new health consumer champion for Devon. It is being established as part of the government's Health and Social Care Act. It will be in place by 1 April.

Healthwatch Devon will establish a new consumer voice which aims to involve the general public and networks of service users, such as older people on a wide range of health and social care issues, and work alongside local organisations to ensure that health and social care developments are kept to the forefront.

Healthwatch Devon will be represented on the newly formed Health and Wellbeing Board.

Who will be involved in Healthwatch Devon?
