## **Health and Wellbeing Outcomes Report**

## Report of the Chief Executive

**Recommendation:** It is recommended that the Devon Health and Wellbeing Board note the first full Health and Wellbeing Outcomes Report and approve the steps outlined in section two for the future development and dissemination of the report.

#### 1. Context

Following on from the approval of the Health and Wellbeing Outcomes Report format in March, this paper introduces the first detailed performance report for the Devon Health and Wellbeing Board, which monitors the priorities identified in the Joint Health and Wellbeing Strategy for Devon 2013-2016.

#### 2. The Health and Wellbeing Outcomes Report

- 2.1 The full Health and Wellbeing Outcomes Report for June 2013 is included separately. The report is themed around the four Joint Health and Wellbeing Strategy 2013-16 priorities, a focus on families, healthy lifestyle choices, independence in older age, and social capital and building communities. The introduction to the report sets out the three indicator types used and further details. Analyses include comparisons of Devon with other upper tier and unitary local authorities in the South West and in the local authority comparator group, local breakdowns by local authority district and Clinical Commissioning Groups (CCGs) and their localities, trend information and the pattern of local health inequalities for the measure. Each individual outcome indicator report also includes a second page detailing technical specifications for the indicator.
- 2.2 Indicators still in development include two measures around access to Child and Adolescent Mental Health Services (one covering referral to first review, and the other referral to effective treatment which will require further local development), the 'feel supported to manage own condition' indicator, which is awaiting the release of standardised GP survey data for 2012-13, and the carer reported quality of life measure, which has not yet been released.
- 2.3 Report elements requiring further development include future trajectories, which are only included for some indicators at present, and CCG breakdowns and local inequalities analyses which are not currently available for all indicators. These issues will be addressed in future versions of the report.
- 2.4 It is proposed that the outcomes report will be made available as an individual section on the Devon Health and Wellbeing website <a href="www.devonhealthandwellbeing.org.uk">www.devonhealthandwellbeing.org.uk</a>, both as a full report, and as individual two page indicator specific reports.
- 2.5 The Outcomes Report should also play a central role in the forthcoming refresh of the Joint Health and Wellbeing Strategy and Joint Strategic Needs Assessment and assist in the identification and refinement of future priorities.
- 2.6 The Health and Wellbeing Outcomes Report will be continually maintained to ensure that the latest information is made available to inform the work of the Board. Future accompanying reports to board will highlight indicators which have been updated since the last report, revealing emerging themes and local progress.
- 2.7 Table 1 provides a brief summary of the main points from the Health and Wellbeing Outcomes Report.
