

Public Health Outcomes Framework Prioritisation Grid for Devon, September 2013

This is a matrix to determine the level of priority afforded in Devon to indicators in the Public Health Outcomes Framework and the reporting processes for them.

Lead Commissioner – Local Authority Public Health, Local Authority General, Clinical Commissioning Group, Public Health England, NHS Commissioning Board, or Joint. **Performance** – Good, Average or Poor compared with national and/or similar local authorities. **Trend** – Improving over time, worsening over time, or staying relatively stable. **Numbers Affected (Scale)** – The number of people affected by measure –high covers areas with risk affecting the whole population or where the total affected per annum runs into thousands, medium covers areas where large sub-sections of the population are at risk or where the total affected is between 100 and 1000, low covers areas where a small subgroup of the population is at risk or where the total affected is less than 100 people per annum.

Human Impact (Individual) – High covers indicators where the outcome is death or severe impairment to health and wellbeing, medium covers outcomes with a moderate impact on health and wellbeing, low covers areas with a small or negligible impact of individual health and wellbeing.

Financial Impact – PH Devon – Cost of commissioning prevention and health services to Public Health Devon. High is £500,000 plus per annum, medium is £50,000 to £500,000 per annum, low is less than £50,000 per annum, none is no direct financial impact on Public Health Devon.

Financial Impact – Wider – Covers the overall cost to the Public Purse across all organisations and services. Limits and criteria still to be determined.

JHWS Outcome – Identifies if the indicator included in the newly established Health and Wellbeing Outcomes Report to the Health and Wellbeing Board.

Availability – yes or no (proxy if not but interim alternative available). Shading – Green – to be included in report, light green – to be included once data is available.

Reporting Process – CORE = Proposed Core Measure (human and/or financial impact significant and needs to be reported to PHLT) IMPROVE = Improvement Measure (performance poor or worse than expected in Devon and improvements needed – needs to be reported to PHLT), MONITOR = Monitoring Only (track through existing Public Health Outcomes tools and possibly existing local reports where available and appropriate – no further detailed regular local reporting to PHLT), N/A = Not Available (yet)
