Health and Wellbeing Outcomes Report

Report of the Chief Executive

Recommendation: It is recommended that the Devon Health and Wellbeing Board note the updated Health and Wellbeing Outcomes Report and approve the proposal under 2.3 for a revised mental health indicator for younger persons.

1. Context

Following on from the first Health and Wellbeing Outcomes Report in June 2013, this paper introduces the second detailed outcomes report for the Devon Health and Wellbeing Board, which monitors the priorities identified in the Joint Health and Wellbeing Strategy for Devon 2013-2016.

2. The Health and Wellbeing Outcomes Report

- 2.1 The full Health and Wellbeing Outcomes Report for September 2013 is included separately. The report is themed around the four Joint Health and Wellbeing Strategy 2013-16 priorities, and includes breakdowns by local authority, district, clinical commissioning group, deprivation and trends over time.
- 2.2 The following indicators have been updated since the last report:
 - Smoking at Delivery (2012-13)
 - Teenage Conceptions (2012 Q1)
 - Adult Physical Activity (2012)
 - Alcohol-Related Admissions (2012-13 Q3)
 - Clostridium Difficile Incidence (2012-13)
 - Feel Supported to Manage Own Condition (2012-13)
 - Effectiveness and Coverage of Reablement Services (2012-13)
 - Social Isolation (2012-13)
 - Carer Reported Quality of Life (2012-13)
 - Stable and Appropriate Accommodation for Social Care Clients (2012-13)
- 2.3 The only indicator still in development is for Child and Adolescent Mental Health Services (CAMHS). The initial proposal was for one covering waits from referral to first review, and the other waits from referral to effective treatment. However, the lack of national benchmarking data and detailed local breakdowns mean this is not possible. In light of this the following indicator, for which national and local information is available, is proposed to cover mental health in younger people:
 - Hospital admissions for self-harm, persons aged 0 to 17
